2024 began with my first session after being sworn in with thirteen other women in the Senate, making up the first-ever women's majority in the Senate Democratic Caucus. I introduced 12 bills, which ranged from expanding public employee work protections, reestablishing the Autism Advisory Council, and the "most sweeping consumer protection measure to emerge in this year's General Assembly session."

A Year in Review: 2024



Bills Signed into Law

- **SB 13**: Permits zoning flexibility to allow localities to establish more child day programs
- SB 389: Reestablishes and expands the Autism Advisory Council
- SB 392: Mandates at least one doctor on duty in ERs at all times

- SB 391: Protects public employees using medicinal cannabis products
- SB 608 Creates the Office of Community Schools at the Department of Education
- **SB 610** Allows individuals with a Developmental Disability waiver slot request slot-retention requests for a period up to 365 calendar days
- SB 726: Requires public schools to carry opioid antagonists such as Narcan

Bills that Passed the General Assembly, Vetoed by the Governor

- SB 225: Notifying parents about safe storage of guns
- SB 393: MEI Project Approval Commission to consider the diversity of boards for businesses requesting state grants
- SB 586: Codifies the use of restorative discipline practices in public schools

Soo Kyung Jung is the director of DI DIM SAE Korean Traditional Art Institute, and she teaches Korean dance and drums at

Centreville and Chantilly High Schools. Finally, I really enjoyed attending high school graduations across the district.
